SUB: Gross violation in Posting of GDMOs having Post Graduate Degree/Diploma/DNB etc.

Respected Sir,

With reference to above cited subject, I want to draw your kind attention that ESIC administration doing gross violation in posting of GDMOs having Post Graduate Degree/Diploma/DNB etc.

1. Posting of Post Graduate GDMOs having Degree/Diploma/DNB in various ESIC Dispensaries under Directorate (Medical) Delhi & Directorate (Medical) NOIDA, is blatant violation of ESIC HQ O.M No. Z-11/Misc/2017-Med.VI dated 25/10/2019 and OM No V-15/15/1/2006-Med-I(MS) dated 20/07/2006.
2. Posting of Post Graduate GDMOs in Casualty/ SST /Billing of various ESIC Hospitals across India & Directorate (Medical) Delhi/NOIDA.
3. Posting of Post Graduate GDMOs having Degree/Diploma/DNB in other Specialty department of ESIC hospital which is not the specialty Department of that PG qualified GDMO.
4. Posting/recruitment of non-PG doctor (MBBS only) i.e. GDMO & Senior Resident doctor in specialty department but our own PG Degree/Diploma/DNB qualified GDMOs are working in various Dispensaries/ Casualty/ SST/Billing department of ESIC Hospitals/ DMD/ D(M)N/ All India.
5. Posting of GDMOs having Degree/Diploma/DNB etc. posted in other Specialty department. For example, GDMOs having Degree in Pathology but posted in Gynecology, Having Degree in Psychiatry posted in Emergency.

Due to administrative failure, Qualified Medical Officers not posted according to their specialized department. Insured persons and their families not getting specialized consultation/treatment.

So, you are requested to look into the matter and give necessary direction to concerned authorities OR pass a speaking order.
