Subject: Regarding Appointment of Head of Department based on seniority at the level of SAG/NFSG at ESIC Hospitals / Institutes.

Respected Sir,

With reference to subject matter cited above, I wish to humbly submit the following for your kind perusal and needful action:

- 1) That as per Govt of India, MOHFW order No. A-45017/01/2018/CHS dated 28 Dec 2018 regarding appointment of Head of Department in Central Govt. Hospitals, the seniority of officer for post of HOD in Central Govt. Hospitals / institutes in a particular department will be decided on date of joining of SAG / NFSG level by a teaching / Non-teaching / GDMO sub cadre.

- 2) This order is currently being followed in CHS Hospitals like RML Hospital, New Delhi etc.
- 3) That as per ESI Act 17 (2), the same CHS orders are to be implemented mutatis mutandis in ESI Hospitals / Institutes.

Hence it is requested that the same orders be adopted by ESIC and implemented in ESI Hospitals / Institutes at the earliest. If fails to do, then ESICMOA have no option other than Court of Law.
