Subject: Regarding Restoration of Post of State Medical Commissioner in ESIC.

Respected Sir,

Please take note of our earlier representation of ESICMOA on 20/03/2018 & 05/07 2018 on the subject matter cited above. In this regard I wish to submit the following for your kind perusal:

- The post of State Medical Commissioner (SMC) was discontinued in year 2017. Subsequently SMOs were posted in lieu of SMC to help / look in day to day matters at state level ESIC.**
- However, the posting of SMOs at the state level has given rise to some fresh issues such as: -
 - These State Medical Officer have relatively less administrative experience as compared to previous SMC.
 - Being junior, these SMOs are naiver to various administrative work.
 - The APAR of these SMOs is reviewed & reported by Regional Director who happen to be a Non-Medical officer. It is surprising how a Non-Medical officer gauges / assesses the efficiencies of a Doctor.
 - There have been instances where Regional Director has forced his whims on SMO & asked him to toe his decisions as the young SMOs are quite gullible.
- Post abolition of SMC, the volume of pending work / bills has increased manifold at each state level. In regards of Empanelment of hospitals, junior Doctor (SMO) can not given his best as compared to SMC (Senior and experienced doctor).
- In Some of the state CMO/NFSG/SAG posted in DCBO and he report to SMO who are junior to him/her. It is extremely unethical practice in ESIC.
- In the light of above facts, I request you to reconsider / review afresh the matter of reinstating the post of State Medical Commissioner.

I hope you will do needful for the better care and management of our esteemed IPs.
