What was the duty hours of ESIC Senior Residents/SR?	The information sought is vague. However, it is informed that no such instruction has been issued, regarding duty hours of Senior Residents, by this branch but it has been made clear in the ESIC HQrs Circular No. V-15/15/1/06-MS-Med.I dated 27/03/2006 that "Forty hours a week working schedule should be adopted for all staff as a norm, except where specified otherwise".
Do senior residents on call for Duty 24hrs?	No such information is available in Medical Branch - 4, HQrs.
ESIC full time specialist/Contractual/Regular or Senior Residents/GDMO allowed private practice legally?	The information sought is vague in nature. However, the permanent/regular employees of ESIC are not allowed to do private practice.
If NO who is responsible to take action against them? Medical Superintendent/Deputy Director/Regional Director or who?	The information sought is clarificatory in nature, which does not fall within the definition of "information" as per Section 2(f) of the RTI Act, 2005. In terms of the provisions of the RTI Act - 2005, the CPIO is not supposed to create information or to interpret the information or to solve the problems raised by the Appellant or to furnish replies to situational queries or to furnish clarifications. However, the disciplinary authority for Group A officers (permanent) is the Headquarters.
Can selection/interview committee repeatedly select same candidates knowing the fact that Candidate have Private practice?	The information sought does not pertain to Medical Branch - 4, HQrs.
What is nature of action against private practice?	The regular/permanent medical officers of ESIC are governed by CCS (Conduct) Rules. Therefore, suitable action for violation of CCS (Conduct) Rules shall be applicable on them.
How to investigate or where to complaint against selection committee if its members are not changed periodically or Investigate any personal relationship or suspected financial transactions?	The information sought does not pertain to Medical Branch - 4, HQrs.
