**ORDER (ORAL)****Hon'ble Mr. Ashish Kalia, Member (J)****MA No. 2318/2023 :**

The instant MA filed by the applicants seeking joining together in a single OA stands allowed for the reasons mentioned therein.

OA No. 1965/2023 :

The applicants have filed this OA seeking the following main reliefs :-

"8a) Direct the respondents to decide the representations dated 02.02.2021 given by the Applicant which is pending before the respondents till the date.

b) Direct the respondent to provide facilities of semi-private/private/deluxe wards as per their levels in pay matrix and any other facilities identical to Central Government Health Scheme (CGHS).

c) Allow the OA with all the consequential reliefs."

2. The main grievance of the applicants is that their representations dated 02.02.2021 followed by several others were not yet decided by the respondents wherein they have sought the benefit of medical services to the medical officers of ESIC as per their entitlement under



Central Government Health Scheme (C.G.H.S.). Hence
the O.A.

3. At this stage, keeping in view the facts and circumstances of the case, we deem it fit and proper to dispose of this OA at the admission stage itself without going into its merits by directing the respondents to decide the latest representation of the applicants dated 03.04.2023 by passing a reasoned and speaking order within a period of 60 days from the date of receipt of a certified copy of this order. It is needless to mention that the applicants are at liberty to re-approach this Tribunal if his grievance still persists.

4. The OA stands disposed of with the above direction.

There shall be no order as to costs.
