**It may be noted that: -**

1. Pay of the above officials on promotion shall be fixed under normal pay Rules & norms as applicable in the subject matter.
2. The promotion will be subject to such terms and conditions as laid down in ESI Corporation (Staff & Conditions of Service) Regulations, 1959, as amended from time to time.
3. In the event of a Medical Officer who is hereby placed in the higher scale being on regular leave / study leave / deputation / foreign assignment etc. on the date of placement, the placement shall take effect from the date she/he had assumed charge.
4. The controlling officers may please ensure that the Medical Officer has completed 7 years service in level-13 of pay matrix including service rendered in the Grade Pay of Rs. 8700 in PB-4 pre-revised scale after excluding the period of EOL availed other than on Medical Grounds/ Study purposes. Though due care has been taken at HQrs level to account for the non-qualifying period (i.e. dies-non/EOL – Not for Medical/Study Purposes) as reported by field units while deciding the due date of said promotion, yet controlling officers may re-verify the service record of the MOs under their control to reconcile the non-qualifying period as reported to HQrs before DPC proceedings. It may be ensured that promotional benefits are granted from the due date only after excluding the total non-qualifying period as there may be any unreported period which could not be taken into consideration at HQrs level. However, the non-qualifying period accounted for by HQrs level in respect of medical officers being promoted under this order is mentioned against each in the table below. Controlling officers & Finance Officers may also ensure that the said non-qualifying period has been taken into account while effecting previous promotions, as applicable in each case. Discrepancy, if any noted, may be brought to the notice of DPC (medical) Cell, HQrs ESIC.
